Be it ordained/resolved by the **Common Council of the City of Woodburn** that for the expenses of **WOODBURN CIVIL CITY** for the year ending December 31, **2025** the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same.
